General information

THE EUROPEAN MUSEUM FORUM

The European Museum Forum (EMF) is an independent not-for-profit organisation which is a charitable company registered in the UK¹, dedicated to promoting innovation in museum practice and encouraging exchange of best practice and ideas across Europe.

- EMF recognises the value of public engagement of museums and fosters excellence through a scheme of annual awards of which the European Museum of the Year Award and the Council of Europe Museum Prize are the main awards.
- Museums considered for the awards are judged in accordance with clear criteria set by EMF, in a process of independent peer review.
- EMF stimulates networking and develops projects to foster exchange of information and good relations between museum professionals and museum volunteers and supporters.
- EMF works through dialogue and consultation with internationally experienced members of the European museum sector and operates under a system of regular renewal and succession-planning to ensure that the organisation always reflects the needs and aspirations of the contemporary European museum community.

THE PURPOSE OF THE EUROPEAN MUSEUM OF THE YEAR AWARD AND THE COUNCIL OF EUROPE MUSEUM PRIZE SCHEME

The European Museum of the Year Award (EMYA) and the Council of Europe Museum Prize were launched in 1977 under the auspices of the Council of Europe, with the aim of recognising excellence in the European museum scene and encouraging innovative processes in a museum world which then still took the more traditional view of focusing exclusively on collections rather than on their use for the benefit of society.

It was an adventurous initiative, with the founders generously investing their prestige and their expertise, together with a lot of time and energy, for something never seen before on this European scale.

The scheme has had a positive influence on the lives of a number of museum professionals and has brought to centre stage small museums with highly innovative contents, which otherwise would not have received recognition at the European level. It has served to establish connections between museums of the East and West, North and South of Europe. Through the work of EMF, the scheme has also directed the attention of public authorities to initiatives originating in their own countries, some of which previously were almost neglected and not recognised at the level they deserved.

Within the scheme, all museums are equal whether public or private, small or large. Whatever their subject, they are assessed on the basis of what is considered outstanding public quality.

THE AWARDS

The EMYA Judging Panel is looking for enterprise and innovation that enhances the public quality of the museum. The judges seek to identify new developments that are likely to have a significant influence in the national and international museum field.

▪ **The European Museum of the Year Award**

EMYA has proven to be the longest running and most prestigious museum award in Europe and continues to be the most important occasion for promoting innovative museum practice and public quality in the European museum sector.

This award goes to a museum which contributes most directly to attracting audiences and satisfying its visitors with unique atmosphere, imaginative interpretation and presentation, a creative approach to education and social responsibility.

Past winners have been both large and small museums, but all developed something, which was special and changed the standards of quality in museums within Europe.

▪ **The Council of Europe Museum Prize (FAQ 12)**

The Council of Europe Museum Prize is a unique award intended to highlight the need to preserve and promote European cultural heritage as a factor uniting the Council of Europe's 47 member states. It involves recognition of the excellence displayed by the winning museums in the approach they take to museum work, while complying fully with the EMYA criteria, and helps to give added dynamism and variety to the European museum sector.

This prestigious prize is awarded based on the recommendations of the EMYA Judging Panel and presented by the Committee on Culture, Science, Education and Media of the Parliamentary Assembly of the Council of Europe. The prize goes to a museum that puts particular emphasis on a clear presentation of a European perspective, and shows initiative in presenting themes of European relevance adhering to the key values and priorities of the Council of Europe, not least those of democracy, human rights and inter-cultural dialogue.

▪ **Kenneth Hudson Award (FAQ 13)**

This is an award in honour of the founder of EMYA, Kenneth Hudson. The award goes to a museum, project or a group of people who have demonstrated the most unusual, daring and, perhaps, controversial achievement that challenges common perceptions of the role of museums in the society and carries forward the spirit of Kenneth Hudson. The Kenneth Hudson Award winner will be chosen by the EMF

Board of Trustees, and will not necessarily be selected from the pool of the EMYA 2018 applicants.

▪ **Sillemto Prize (FAQ 14)**

This prize is sponsored by the Sillemto Foundation based in the Isle of Man and goes to a museum which has in the past three years demonstrated excellence in involving its local community in planning and developing museum and heritage projects or has attracted outstanding support from its work with volunteers with the goal to enhance the public quality of the museum.

▪ **Special Commendations (FAQ 15)**

A number of special awards will also be given to museums that have developed a new and innovative aspect of their public service and from which other European museums can learn. In 2018, a Special Commendation for Sustainability in Museums will be offered by Meyvaert Glass Engineering. Other Special Commendations are open-ended.

Guidance notes for the application process and participation in the 2018 EMYA and Council of Europe Museum Prize competition

ELIGIBILITY

- Any new museum or any museum substantially renovated or redeveloped, can apply.
- Temporary or 'semi-permanent' exhibitions can be the subject of an application. It has to be noted that museums/exhibitions need to be open/completed in time for the judging visit (summer – early autumn 2017) and have to remain accessible until at least the end of June 2018.
- Museums/exhibitions opened for more than 3 years at the time of the application, are not eligible.

EMYA 2017 APPLICATION FORM

1. Application form

The EMYA 2018 Application Form is to be completed online: <http://europeanforum.museum/join-now/>.

Please make sure that you also provide a description of the project in a separate document (maximum 1,500 words) and upload this in conjunction with the application form.

The application should be submitted in English.

2. Supporting material to accompany the application

Supporting material should be uploaded in the online-form.

Please carefully read the guidelines below.

All candidates should provide the following information:

1. Illustrations: **(FAQ 11)**

- A maximum of 20 digital images, in JPEG format. These images should be no less than 300 dpi and be at least 1000x1000 pixels in size. The image files must be of a suitable quality for reproduction and projection and each image must be given a unique file name. The images should include at least one exterior view of the museum and general views of the galleries and activities. We do not require images of individual items.
- Please note that these images will be used by the EMF in a number of ways, including publication of a selection in the annual candidates' brochure. The images must be of a good quality, free of copyright and available for use in the Annual EMYA publications and on the EMF web site. If you are invited for Public Interview at the EMF Annual Assembly 2018, these images could be projected to illustrate the museum and the work done by your organisation.

2. A copy of the bank transfer instructions for the entry fee, uploading it at <http://europeanforum.museum/payments/>.

3. Any other digital material which you may wish to send to us separately. This could include electronic versions of the Museum's leaflets, brochures or catalogues and a small selection of relevant press cuttings.

- If you intend to submit other supporting material via a file-sharing website you should send EMF a notification of the upload (to emf@europeanforum.museum) and also ensure that the files will be available for download by us for at least one month from the date you upload the files. We would appreciate the upload of complete folders rather than multiple uploads of individual files.
- A content list of all accompanying material must be sent to us.

Please note: All paper and electronic material will be retained in the EMF Archive after the judging has taken place. The archive is held at the Institut für Museumskunde in Berlin, Germany.

THE JUDGING PROCESS

All candidates are considered by the EMYA Judging Panel, which is an independent international expert body appointed by the EMF Board of Trustees. Judges are not remunerated by EMF for their participation in the judging process.

Museums applying to enter the competition will be judged in the following way:

1. A careful assessment of the application form and supporting material. We reserve the right to decline applications if we believe that the basic criteria for entry have not been met.
2. The EMYA Judging Panel will agree on a long list of candidates from the remaining applications.
3. A visit by an EMYA Judge will take place to all long-listed museums during summer/autumn 2017. Arrangement of the Judge's visit will be agreed with the museum once the long list has been approved by the Judging Panel.
4. After the initial visit, another EMYA Judge may visit a candidate museum anonymously for the second time at the decision of the Judging Panel.
5. The EMYA Judging Panel meets in November 2017 to consider all Judges reports and make decisions on the Nominated (short-listed) museums and on the winners.

6. Nominated museums are expected to present themselves during the EMF Assembly and EMYA Ceremony 2018, which is to be held in Warsaw, Poland.
7. Winners are announced on the last day of the Assembly in a formal Ceremony and Gala celebration.
8. Winner of the Council of Europe Museum Prize may be announced earlier, at the decision of the Council.

COMPETITION ENTRY FEE

The completed application form should be accompanied by an **entry fee of 500 EURO**.

Please note that your participation in the annual EMF Assembly and EMYA Award ceremony will be subject to additional costs including registration, travel and accommodation. These costs are not included in the competition entry fee.

Payments should be made by **bank transfer**. Please note that the applicant must pay for any bank charges incurred. Please make sure that your payment is identifiable, by including the name of the museum and the town in which it is situated as a payment reference.

Loans policy for award winners of European Museum of the Year Award and Silletto Award

- The winners of the European Museum of the Year Award and Silletto Prize are handed a statuette to display in their museum for one year.
- Borrowers are obliged to provide facilities (environmental, security, insurance, packing and transport for the hand-over etc.) to maintain the award in appropriate conditions and cover the related expenses.
- The borrower should indemnify the award trophy (EMYA Award, Silletto Prize) against all insurable risks from the moment it is handed over until its return to EMF at the subsequent EMF Annual Assembly and EMYA Ceremony.
- The EMYA winner is expected to give a brief presentation about the impact of the award during the subsequent EMF Annual Assembly and EMYA Ceremony.
